

## **15. BÖLÜM**

### ***CİNSEL SUÇLARDA SOSYAL MEDYA ETKİSİ***

#### **Giriş**

Tarih boyunca süregelen teknolojik gelişmeler bireyin yaşam serüveninde oldukça büyük değişikliklere sebep olmuştur. Özellikle medya kavramının ve buna bağlı olarak çeşitli medya araçlarının ortaya çıkması, sosyal, kültürel, toplumsal ve daha birçok alandaki gelişmelerin daha geniş kitlelere ulaşmasını sağlayarak bir bilgi toplumu yaratmıştır. Günümüzde, özellikle internet kavramının da gelişimiyle birlikte geleneksel medya araçlarında sıkça gördüğümüz zaman ve mekân sınırlamaları da ortadan kalkarak birey ve toplumun erişim ağını genişletmiş; dünyanın herhangi bir yerinde meydana gelen bir olaya vakıf olmak oldukça kolay hale gelmiştir (Hilbert, 2012). Bahsedilen bu gelişmelerin en güncel de sosyal ağ kavramının doğması olmuştur.

Sosyal medyanın bireylerin hayatına girmesiyle birlikte, insanlar arası iletişim çok büyük bir değişime uğramış; anlık bilgiye ulaşmanın bu kadar kolay hale gelmesi bilgi akışını oldukça hızlı hale getirmiştir ve ani bir değişim süreci başlatmıştır (Sajithra ve Patil, 2013). Bu bağlamda sosyal medya “Kullanıcıların, oluşturduğu içerikten ve başkalarıyla etkileşim algısından değer kazanarak eş zamanlı ya da eş zamansız olarak, kendi faydasını gözetecek şekilde kendini sunmasına ve hem
