girip uyguladıktan sonraki 2. ayda uygulamanın kullanımında ciddi bir düşüş bildirildi ve indirmeden sonraki 1. yılda kullanıcıların %1'inden azı uygulamayı en az haftada bir kez kullanmaktaydı.<sup>22</sup>

Teletıp son yıllarda gelişmiş ve ilerlemiştir. Teletıbbın yararlarını evde diyaliz hastalarını kapsayacak şekilde genişleten yeni kılavuzlar, bu hastaların daha iyi bakım alması noktasında bu teknolojinin daha ileri kullanımının kapılarını açmıştır. EHD'ye giren böbrek hastalarında teletıp kullanımının sonuçları hakkında veriler halen eksik olup, bu konudaki bilgi temelimizin artırılması için geniş randomize çalışmalar gereklidir.
