Stigmatize/stigmatizasyon (damgalama) en az depresyon ve diğer ruhsal belirtiler kadar kişilere zarar verme potansiyeli taşıyan ve mücadele edilmesi gereken bir halk sağlığı sorunudur. Bu sorun, COVID-19 pandemi sürecinde kişileri psikolojik açıdan savunmasız bırakan etkenlerden biri olarak karşımıza çıkmaktadır.

Bu bölümde;

- Stigma (damga) farkındalığının salgınlarla mücadele bileşenleri arasında ilk sıralarda yer alması gerektiğine vurgu yapmak,
- Damgalamanın sosyal belirleyicilerinin COVID-19 ile ilişkisini anlamak, hastalıkla ilgili daha etkili girişimler geliştirilmesine yardımcı olabilmek amacıyla, “damga”, “damgalama”, “salgın hastalıklar ve damgalama”, “COVID-19 ve damgalama”, “sağlık çalışanları ve damgalama”, “COVID-19 pandemi sürecinde hemşirelik yaklaşımı ve damgalamanın yönetimi” konuları tartışılmıştır.
