► 1. Giriş

1.1. Araştırmaya Genel Bir Bakış

Bu çalışma, ortaokul öğrencilerinin serbest zaman aktivitesi olarak okul spor faaliyetlerine katılım süreçlerinde etkili olan unsurları keşfetmeyi ve bu süreçlere bütüncül bir açıklama getirmeyi ele almaktadır. Başlangıçta bu araştırmanın modeli bütünü ile ileriye dönük olarak tasarlanmamıştır. Model tasarımlı ve stratejisi ile ilgili kararlar süregelen olmakla beraber, araştırmanın pratiği ve bağlamını temel almıştır. Buna bağlı olarak araştırma tek fazda gerçekleştirilmiş ve nitel araştırma yöntemleri
