İnsan ve hayvan ısırıkları ile böcek sokmaları, birinci basamak sağlık kuruluşları ve acil servis başvurularının önemli nedenlerinden biridir. Bu yaralanmalar başta enfeksiyon olmak üzere çeşitli komplikasyonlara neden olmaktadır. Ancak ısırık ve sokmaların çoğu önlenabilir durumlardır.
