

Nörogelişimsel Bozukluklara Evrimsel Bakış

Özet

Dikkat eksikliği hiperaktivite bozukluğu (DEHB) ve otizm spektrum bozukluğu (OSB) olmak üzere iki nörogelişimsel bozukluğu evrimsel perspektiften tartışmaktadır. Her iki tablonun da genetik bir temeli olup, bu genlerin doğal seçimin sürecinde neden hayatı kalmış olabileceğini araştırmaktayız. Bunu yaparken, geçmişte avantaj sağlamış olan bir özelliğin ortam değiştiğinde dezavantajlı hale gelmesi anlamına gelen evrimsel uyumsuzluk kavramından yararlanmaktadır. Ayrıca bu rahatsızlıklar üzerindeki genetik olmayan etkileri de açıklamaktayız. Nörogelişimsel sorunları olan çocukların istismara uğrama ihtimalinin daha yüksek olduğunu, dolayısıyla hem genlerin hem de çocukların içinde büyündüğü çevrenin önemini vurgulamaktayız. Avcı-toplayıcı toplumlarda, DEHB risk alma eğilimini desteklemiştir olabilir, bu da DEHB'nin neden günümüze kadar geldiğini açıklayabilir. Çocukların günün büyük bir bölümünde saatlerce hareketsiz oturmalarının beklentiği çağdaş okul modeli ise bu durumu desteklememektedir. Bu nedenle DEHB'yi evrimsel uyumsuzluk açısından anlamak, hem ilaç tedavisi hem de okul ortamıyla ilgili etik sorunları gündeme getirmektedir. OSB'ler ise oldukça heterojen bir yapıda olup, tablo yüksek kalitim ve azalmış üreme şansı ile karakterizedir. Spektrumun ağır ucundaki OSB'ler oldukça dezavantajlı bir pozisyondadır ve genellikle zihinsel yetersizlikle birlikte görülür. Spektrumun diğer ucundaki yüksek işlevli OSB ise evrimsel olarak spesifik becerilerin geliştirilmesi bakımından adaptif olması nedeniyle günümüze kadar gelmiş olabilir.

Anahtar Noktalar

- Evimsel düşünce, çocukluk çığı gelişimsel bozukluklarına dair yaklaşımımızı derinleştirebileceği gibi ve bu bozuklukların klinik tedavisine yardımcı olabilir.
- *Evimsel uyumsuzluk (evolutionary mismatch)* kavramı, özellikle nörogelişimsel bozuklukların горече yüksek prevalansını anlamamızda yardımcı olabilir. Bu kavram, geçmişte avantaj sağlamış olabilecek, ancak şimdi çevredekide değişiklikler göz önüne alındığında dezavantajlı hale gelmiş durumları ifade eder.
- Evimsel geçmişimizde, çocukların bir günde uzun saatler boyunca yerinde oturup akademik görevlere odaklanması beklenmemiordu. Dikkat eksikliği hiperaktivite bozukluğu (DEHB), adap-

tif yenilik arayışını ve risk almayı desteklemiş olabilir. DEHB'yi evimsel uyumsuzluk bakışı ile ele almak, çocukluk çığı DEHB'sinin yönetimine ilişkin etik sorunlar da dahil olmak üzere önemli konuları gündeme getirir.

- Otizm spektrum bozuklukları (OSB'ler) oldukça heterojen olmakla birlikte yüksek kalitim ve düşük üreme başarısı ile karakterizedir. Spektrumun şiddetli ucunda, eğer zihinsel yetersizlik de eşlik ediyorsa OSB oldukça dezavantajlı olabilir. Diğer taraftan, yüksek işlevli otizm evrimsel geçmişimize uyum sağlama sonucunda bugün uygun çevrede bu şekilde ortaya çıkmış olabilir.

15.1. Giriş

Klinisyenler ve bilim adamları olarak, psikiyatride halen baskın olan geleneksel hastalık modelinin,

sal ilaçlar ya da yasadışı uyuşturucu madde (Ross vd., 2015) kullanımını söylebilir. Bellek ve dürtü denetimi de dahil olmak üzere birçok beyin bölgesinde yıkıcı etkileri olan fetal alkol sendromu (Mohammadzadeh ve Farhat, 2014) oldukça tehlikeli bir durumdur (Rangmar vd., 2015). Sonuç olarak, evrimsel geçmişimizdeki hiçbir şey bizi günümüzdeki kadar erken doğan prematüre fetüslerin hayatı kalma olasılığına hazırlamamıştır. Dolayısıyla pek çok prematüre bebek ciddi nörogelişimsel sorunlar yaşamaktadır (Jarjour, 2015).

15.4 Sonuç

Evrimsel bir bakış açısının DEHB ve OSB ile ilgili tartışmalara katkı sağlayacağını düşünmektedir. Bu durumları belirli ortamlarda adaptif değeri olan biyolojik varyantlar olarak değerlendirmek, çocukların “yaramaz” veya “anormal” olarak görülmüşinden ziyade ev-

rimsel uyumsuzluk yaşadıklarını algılamaya yardımcı olacaktır. Örneğin, okuldaki eğitim stratejileri, DEHB olan çocuklara bol miktarda fiziksel aktivite sağlama ve OSB olanların özel yeteneklerini destekleme üzere odaklanmalıdır. Belki de ilerleyen zamanlarda okulların nasıl kavramsallaştırıldığı ve işletildiği konusu da yeniden gözden geçirilmelidir. DEHB ve OSB olan bireyler için evrimsel bakış açısı, bu bireylerin güçlü yönlerini farkettmelerine ve bu yönlerinin değer gördüğü meslekler aramalarına da yardımcı olacaktır. Muhtemelen tüm insan mizaçlarında olduğu gibi bu koşullarda da kaçınılmaz olarak olumsuz durumlar yaşanacaktır. Ancak, bu durumların evrimsel kavramlarla yeniden açıklanması, etyoloji, tanı ve tedavideki karmaşıklıkları azaltıp bu kişilerle ilgili etik ve sosyal sorumluluklarımızın daha bilinçli şekilde tartışılmamasının önünü açacaktır.
