ADLI PSİKIYATRİ PERSPEKTİFİNDEN ÇEVİRİM İÇİ / SİBER SUÇLARA YAKLAŞIM

GİRİŞ

İnternet, geleneksel suçların yeni biçimler alması için tamamen yeni fırsatlar ve ortamlar yaratmıştır. İnsana yönelik, mala yönelik ve kamu düzenine yönelik bir çok suç günümüzde internet ve diğer teknoloji imkanları vasıtasyyla gerçekleştirilebilmektedir. Yasadışı çevrim içi bahis oyunları, terör aktiviteleri, uyuşturucu/uyarıcı madde ticareti, çocuk pornografisi bulundurma, yayma, ve çocuklara ve erişkinlere yönelik diğer cinsel suçlar, hakaret, tehdit, ısrarlı takip, zorbalık ve diğer şiddet suçları, şantaj, kişisel bilgilerin ele geçirilmesi, dolandırıcılık ve soygun gibi pek çok geleneksel suç internet ortamında olmaktadır (1–4).

Teknoloji, bilginin yanında ve geniş bir şekilde yayılmasını sağlayan internet ve uzaktan iletişim, taciz veya takip etmek için gereken çabayı, maliyeti ve enerjiyi büyük ölçüde azaltmaktadır. İnsana yönelik suçların teknoloji ve çevrim içi şartlarda artış göstermesinde internetin anlık kullanım kolaylığı ve yaygınlığı, mağdurla iletişim kurma imkanının daha rahat oluşu, sanal ortamda fantazi ve realite ayrımlının ortadan kalkması, suç davranışında bulunanları cesaretlendiren anonimlik ve internette yayınlanan ögelerin kalıcılığı rol oynamaktadır (5–7). Internet yoluyla gerçekleştirilen insana yönelik suçlarda suçu mağduru çevrim içi olarak taklit edebilir, mağdur hakkında kolaylıkla bilgi toplayabilir, hakaret ve tehdit içerikli veya kısırtıcı gönderiler yazabilir, mağdura cinsel veya şiddet içerikli uygunsuz görsel veya işitsel içerik veya
