güçlendirilmesi üzerine, aile temelli, okul temelli, çevre temelli, medya temelli ve toplum temelli ortamlarda sunulmaktadır. Önlemeye yönelik ülke politikalarına, tedaviye yönelik iyileşme politikalarından daha çok yatırım yapılmaktadır. Bağımlı bir bireyin, topluma ekonomik olarak getirdiği yük daha fazladır. Bağımlı bireylerin toplum temelli tedavi merkezlerinde, ayakta tedavi ve yatarak tedavi merkezlerinde rehabilitasyonu ve yeniden topluma kazandırılması için kanıta dayalı uygulamalar ve müdahaleler ile tedavi edilmesi önemlidir.
