Konuşma Bozukluklarının Değerlendirilmesi

Normal konuşma üretimi, bir dizi koordineli olaydan oluşmaktadır. Artikülatörlerin tam olarak uygun pozisyonda yerleştirilmesini, sıralanmasını, zamanlamasını, yönünü ve gücünü gerektirmektedir. Bu durum, kesin hava akımı değişikliği, fonasyonun başlatılması veya durdurulması ve velofaringeal eylem ile aynı anda gerçekleşmektedir. Konuşma bozukluğu, bu karmaşık süreç bozulduğunda ortaya çıkmaktadır. Konuşma bozuklukları organik veya fonksiyonel etyolojilerden kaynaklanmaktadır (1). Örneğin; yapısal anormallikler organik etyolojiler arasında yer almaktadır. Yapısal anomaliler intrauterin dönemde embriyonun gelişimsel duraksamaları sonucunda; kulak, göz, burun, ağız boşluğu, girtlak, boyun ve yüz bölgelerinde ortaya çıkmaktadır (2). Yapısal anomalilere örnek olarak hipotroide bağlı hipoglossal dil Resim 1'de gösterilmiştir.

yaygın paternlerin çoğunu temsil eder ve fonolojik bozukluğu olan çocukların ses hatalarını analiz etmede yaygın olarak kullanılır. Türkçe konuşan çocuklar için fonolojik işlemler ve sonlanma yaşları Tablo 6'da belirtilmiştir (57).
