## GİRİŞ

İlk kez Çin'de Aralık 2019'da; ilk kez tespit edilen Şiddetli Akut Respiratuvar Sendrom Koronavirüs-2 (SARS-CoV-2) olarak adlandırıldı COVID-19'un yaptığı salgın, Dünya Sağlık Örgütü (WHO) tarafından 11 Mart 2020'de 'Pandemi' olarak ilan edildi. Bu tarihten itibaren tüm dünyada pek çok çalışma pandemiye ait katı önlemlerin ışığı altında yürütüldü.

Dünyanın yaşadığı bu yeni tecrübe bilim insanları da birçok bilgiyi güncelleyerek hızlı bir akış sağladı. Bu süreçte ülkemizde ve dünyada veriler hızla ve el-
